

**The Daniëlle Children's Fund Foundation** processes personal data. In this Privacy Statement you will read what personal data are processed for, how you can exercise your privacy rights and you will receive other information that is relevant to you in this respect. This privacy statement applies to all activities of **the Daniëlle Children's Fund Foundation**, including our website.

## **General**

The protection of the privacy of our (former) donors, volunteers and suppliers is important to us and that is why we are without doubt careful with these data. For proper performance of tasks, it is important to record a number of data, including personal data. We use this information, among other things, to record and execute agreements and to provide optimum service to our donors. We do not process more data than absolutely necessary and treat it confidentially. The Daniëlle Children's Fund Foundation treats and protects personal data with the utmost care and processes them according to the European Regulation GDPR: General Data Protection Regulation.

## **For what purposes does the Daniëlle Children's Fund Foundation process your personal data?**

We process personal data in order to be able to carry out various services and tasks properly. This is done on the basis of permission or because of the legitimate interest. This involves the following activities:

- Engaging and executing agreements with donors.
- Processing and administering donations, contributions and commitments.
- Sending newsletters and from the Daniëlle Children's Fund Foundation.
- Correspondence with those involved / donors, including thank you messages and e-mailing Christmas messages.
- Compliance with the legal obligation to register.
- The archiving of data in legal proceedings, should this be the case.
- Collecting information for policy purposes for the board.

## **What personal data does the Daniëlle Children's Fund Foundation collect?**

We record the following data (if possible):

- Name and address details (name, address, place of residence)
- telephone number
- e-mail address
- interaction data (eg. information from / about contact between you and the Daniëlle Children's Fund Foundation)
- We receive the personal data through the contact with you, but if necessary, the Daniëlle Children's Fund Foundation will also receive personal data via third parties to the extent that this is legally permitted.

## **How does the Daniëlle Children's Fund Foundation ensure confidential handling of personal data?**

- The Daniëlle Children's Fund Foundation takes appropriate technical and organizational measures to protect personal data.
- Your personal data will not be rented, sold or otherwise shared with or provided to third parties.
- The Daniëlle Children's Fund Foundation provides personal data to enforcement authorities or anti-fraud organizations when this is necessary to comply with a legal obligation.
- Your personal data is stored in accordance with the GDPR and no longer than strictly necessary to achieve the purposes for which the data were collected.

## **How can you 'view', change or delete your data?**

You can send a viewing or correction request to Daniëlle Children's Fund Foundation. Clearly indicate that this is a request for perusal or correction under the GDPR. You can also request that your data be deleted. However, this is only possible as far as the legal obligations permit; that applies in particular for the statutory storage periods.

You are entitled to file a complaint about the use of your data with the Dutch Data Protection Authority. On the website of this Authority you will also find extensive information about the GDPR and everything that has to do with personal data.

We respect this obligation to report. Those involved will be informed if this is the case in the context of this duty to report.
